Rating Rationale and Key Rating Drivers

The assigned rating reflects modest positioning of AWT Investments Limited ("AWTIL" or the "Company"). The prominent business acumen of the sponsor bodes well for the rating. The rating is supported by a structured investment process, sound governance structure, proficient and qualified management. The Company is also strengthening its foot prints in the competitive investment advisory domain, The management is also planning to diversify its product slate by launching hybrid REIT schemes and private equity funds. The AUMs' profile of the Company remained stagnant with average market share ~0.2% during FY21. The retail clientele under SMA portfolio constitutes ~68% reflecting granularity. The association of SMA spans an average from 1 year to 3 years, while the portfolio mainly comprises of discretionary SMAs. Since Jun'20, the Company have shown a healthy growth of ~100% in SMA portfolio. The Company is in the process of completion of an in-house owned Software Solution for the Investment Advisory business which will further solidify its position in the market. Previously, the Company is in losses on account of declining management fee, but over the time, the fee has been improved on the account of advisory business, the Company has reported a net profit of ~PKR 5.4mln in Mar'21 (Jun'20: ~PKR -39mln). The Company's equity stood at ~PKR 233mln at end Mar'21. The conversion of losses to profits is itself indication of efficiency of management and its commitment to bolstering bottom-line.

The rating is dependent on the Company's ability to strengthen its market position. At the same time, stability in key human resource, structured improvement in risk management framework and success of initiatives to increase retail AUM will remain crucial for the rating.

Profile

Structure AWT Investments Limited ("AWTIL" or the "Company") is a public unlisted company incorporated in August 2011.

Background The Company was is registered as an Asset Management Company and Investment adviser under the Non-Banking Finance Companies Regulations by the Securities and Exchange Commission of Pakistan (SECP). Head office of the company is situated in Rawalpindi.

Market Share The market share of the company stood at 0.2% since Jun'20.

Diversification Of Fund Mix The Company offers investment solutions for both conventional and Islamic markets. At FY21, AWTIL is offering 4 Funds in Equity and Fixed Income Category, in order to diversify its fund slate, it has converted the asset allocation fund to money market category. It would soon be launched, the PACRA has assigned initial rating of "AA+" to AWT Money Market Fund.

Investor Concentration The average Top 10 investor concentration at Mar'21 is ~79% as compared to ~41% at Jun'20 and the average related party holding represents ~18% of total AUMs.

Ownership

Ownership Structure AWTIL is a wholly owned subsidiary of Army Welfare Trust (AWT).

Business Acumen The assigned rating takes into account sound profile of the existing sponsor, AWT, which has more than 4 decades of experience in the financial services sector, operating companies under the "Askari" brand in banking, insurance, leasing, financial services and asset management industries.

Financial Strength The financial strength of the sponsor, the Askari Group of Companies, remains strong due to its diversified profitable businesses. The support of sponsor as indicated by equity injection of Rs. 100m in FY19 and another injection of Rs. 100m in January 2020 in the form subordinated loan to ensure compliance of AWTIL with Minimum Equity Requirement (MER) for Asset Management and Investment Advisory Companies.

Governance

Board Structure The Company's board consists of six members, including the CEO. The board comprises five non-executive and one executives director.

Members' Profile The Chairperson, Lt. Gen Naveed Mukhtar is a graduate of Pakistan Military Academy; The Cavalry School, France; Command and Staff College Quetta; Joint Command and Staff College, Philippines; National Defense University, Pakistan; and The United States Army War College. Naveed Mukhtar has served in a variety of command and staff positions at nearly every level during both peace and operations.

Board Effectiveness There are two committee, namely 1) Human Resource Committee and 2) Audit Committee for effective monitoring and board assistance.

Transparency The internal audit department is outsourced to M/S Yousaf Adil Chartered Accountants for effective monitoring of control systems. The external auditor of the Company is M/S RSM Avais Hyder Liaquat Nauman Chartered Accountants, which falls in the 'A' category of SBP Panel of Auditors.

Management

Organizational Structure The Company has a well-defined and formalized organizational structure, with appropriate departmentalization. It operates through five departments, each with its well-defined and specific functions.

Management Team The senior management team of AWT Investment Limited comprises qualified and experienced professionals. The CEO, Mr. Salman Haider Sheikh has over 24 years of global Investment Management and Investment Banking with 13 years as a successful CEO being instrumental in establishment and growth of Two Large Financial Institutions with a proven track record and independent acknowledgements. His forte also includes Private Equity transactions and Structuring of Investment products. Mr. Basharat Ullah is the chief investment officer. He has extensive experience of 25 years in Pakistani capital markets primarily in the field of investment management and buy/sell side research. He has worked in both asset management and brokerage industry, with 11 years in the mutual fund sector.

Technology Infrastructure The Company is using software designed by Softech Company for the accounting and funds' management solutions. The Company is also in the process of ERP evaluation.

Control Environment The compliance is being led by Mr. Asif, having over 12 years of professional experience in Compliance, operations, audit and assurance, Prior to joining. The Company has devised detailed policies to ensure compliance with all applicable statutory regulations and internal investment guidelines. The company uses excel based models to monitor the exposure limits and margins.

Investment Risk Management

Credit Risk The Company used excel based credit risk models for credit risk monitoring with focus on qualitative and quantitative analysis. The Company has controls in place to ensure exposure limits.

Liquidity Profile The risk management department vigilantly monitors the liquidity profile of the Company. Sufficient liquidity is maintained by investing a significant portion of funds assets in liquid investment avenues.

Market Risk For managing market risk, various techniques such as VaR analysis, beta analysis and stress testing are being used. The exposure limits are clearly communicated to portfolio managers along with periodic review of appropriateness of limit structure.

Portfolio Management

IC Composition The investment committee comprises of the Chief Executive Officer, Chief Finance Officer, Chief Investment Officer, Head of Risk and Compliance and Fund Manager.

Effectiveness The investment committee comprises of qualified and experienced professionals. The investment committee meets on weekly basis and reviews the investment strategy of each fund under management and its performance on regular basis to incorporate the impact of market circumstances on funds' performance.

Investment Research And Analysis The research function operates under the supervision of Chief Investment Officer. The department uses various techniques including the fundamental analysis of key sectors and stocks to identify attractive investment avenues. For equity valuation, standard financial models are used and broker researches also considered.

Customer Relationship

Investor Services The Company is providing adequate services to its clients. The marketing team is responsible for maintaining relationship with existing and prospective clients. In order to remain competitive, the Company has been implementing strategies for integrating information technology in all the processes of the Company to facilitate its customers. The Company has provided its investors with an online platform which allows real time access to their accounts. The mobile app of the Company provides various value-added services such as fund NAVs, investment account details and E-transactions.

Investor Reporting The Company disseminates unit holder statement on monthly basis which comprises investment value and asset allocations. The Company disseminates and publishes FMR on its website in a timely manner.

Distribution And Sales Network The Company has five branches, of which two are in Karachi, and one each in Lahore, Multan and Rawalpindi

Performance

Asset Under Management Since Jun'20, the AUMs of the Company declined by ~27%, currently stood at PKR ~1.9bln. The company's SMA portfolio observed a increase in its AUMs in comparison to previous year. The funds performance of the Company remained below industry average but beat the benchmark.

Asset Manager The core income of the Company has increased by ~176% and stood at PKR 58mln (Dec'19: PKR 21mln). During 1HFY21, the Company reported after tax profit of ~PKR 66mln (1HFY20: ~PKR -14.7mln). The Company's equity stood at ~PKR 233mln at end Mar'21, which meets the minimum equity requirement.
