Rating Rationale and Key Rating Drivers

The ratings of Bank AL Habib Limited reflect its enduring and sustained emphasis on reinvigorating its relative positioning in the peer universe. While the competitive landscape is becoming increasingly intensified, the Bank, under its able leadership, is actively taking measurable steps to remain competitive and, indeed, improve its positioning. As of 9MCY24, the Bank's deposit base grew by 15%, reaching PKR 2,222bln (CY'23: PKR 1,934bln). The major influx has been experienced in the customer deposits grew by ~17% during 9MCY24. The overall deposit mix in terms of CASA ratio has also been improved to ~75% as of the end Sep'24 (Dec'23: 71%). The gross advances stood at PKR 814bln (CY'23: PKR 896bln). Subsequently, the advance share of the Bank clocked at 7.0% (CY'23: 7.2%). The non-performing loans of the Bank reported an increase of 38% to PKR ~35bln (Dec'23: 25.2, Dec'22: 15bln). The resulting infection ratio recorded an uptick to 4.29% as of ended Sep'24 (Dec'23: 2.8%). During 9MCY24, the investments increased to PKR 1.81trln (Dec'23: PKR 1.5trln). The resultant ADR declined to ~37% as of the end of Sep'24 (Dec'23: 46%). During 9MCY24, the Bank reported a Profit After Tax of PKR 33bln (9MCY23: 29.2bln, CY'23: PKR 35bln), while Net Interest Margin Revenue (NIMR) was PKR 116.5bln (9MCY23: 84.8bln, CY'23: PKR 124bln). Markup income from the expanded investment portfolio and a 33% increase in other income (branch banking, commission on trade and card related fees) were key drivers of profitability during 9MCY24. The CAR of the Bank reflected an improvement to 19.63% (CY'23: 15.8%) owing to healthy profitability.

The rating is dependent on the Bank's sustained risk profile. The equity base of the Bank and CAR is satisfactory and may continually be enhanced.

Issuer Profile

Profile Bank AL Habib Limited ("BAHL" or the "Bank"), incorporated as a public limited Company, commenced operations as a Scheduled Commercial Bank in 1992. The Bank is quoted on the Pakistan Stock Exchange under the category of commercial banks. The Bank's registered office is located in the city of Multan in Punjab and its principal office is located in Karachi. The Bank's principal activities are to provide commercial banking services to individuals and institutional clients. The Bank has an existing branch network of 1,190 as of the end-Sep24 (end-Dec23: 1,113) branches /sub-branches, including 256 (end-Dec23: 201) Islamic banking branches. BAHL has been operating overseas branches in the Kingdom of Bahrain and Malaysia (Labuan) and one representative office each in Dubai, Istanbul, Beijing, and Nairobi.

Ownership Habib's Family and friends, associates, and group companies own a majority stake (50.7%) in BAHL. Other major shareholders include State Life Insurance Corporation (6.6%) and National Investment Trust (5%). The ownership structure of the Bank is seen as stable as the majority stake rests with the sponsors. Sponsors are members of the Habib Family - one of the oldest and most distinguished names in Pakistan's banking sector. Their significant can't experience and business acumen in commercial banking have been of value, as their background has allowed them to proactively deal with the changing dynamics of the industry and demonstrate consistent performance. BAHL is the flagship business of sponsors. Hence, willingness to support the Bank in case the need arises is considered high; also supplemented by access to the capital markets

Governance BAHL's ten-member BoD includes three representatives of Habib Family. Three members are independent directors while one is executive director. In addition, the CEO is deemed to be a director. During April 2024, Mr. Javed Iqbal resigned from the position of independent director. The board members have extensive experience in the banking and commercial industries of Pakistan and are actively involved in providing strategic input and guidance to the management. CEO is a seasoned professional banker, who has been with the Bank for over 28 years. There are six board committees that assist the board in the effective oversight of the Bank's overall operations on relevant matters. The BoD provides overall guidelines on managing risks associated with the Bank's operations and strategic direction. The auditors of the Bank are EY Ford Rhodes, Chartered Accountants, classified in category 'A' by SBP and having a QCR rating. They have expressed an unqualified opinion on the Bank's financial statements for the year ended December 31, 2023.

Management The Bank has well-developed management tiers and succession plans for key management positions and a horizontal organizational structure, wherein the company's operations are grouped under various Division Heads. The strength of the Bank comes from the core team of experienced senior banking professionals, who have sizable experience in commercial banking, locally and abroad. The Bank has five internal committees in place at the management level to oversee its day-to-day operational matters and take decisions to implement the strategy outlined by the board. The Bank is using in-house developed software named 'AL Habib Banking System -AHBS' as its core banking software that allows real-time online connectivity with other subsystems operating in the Bank. The Bank also has a separate Information Security Department. BAHL has a robust risk management framework to manage various risks to which the Bank is exposed. The overall responsibility of risk management lies with the BoD, through various committees of the board. The Bank has in place a separate Risk Management Division (RMD).

Business Risk In 9MCY24, Pakistan's listed banks demonstrated resilience amid low-interest rate environment. Although year-on-year profitability saw a slight dip, quarterly performance improved, driven by volume growth and favorable repricing effects. Provisioning charges for the quarter ending September 2024 rose by approximately 28%, reflecting the impact of IFRS-9 implementation and sector-specific pressures, particularly in the textile and steel industries. At end-Dec23, BAHL, a large-sized Bank, holds a good position in the industry; market share in terms of total deposits reported at 6.8% (end-CY22: 6.9%), which increased further to 7.01% at the end Sep'24 on the back of major influx in saving deposits in the individual customer base. At end Sep'24, the Bank's deposit base stood at PKR 2,222bln (CY23'23: PKR 1,934bln, CY22: PKR 1,568bln). During CY23, BAHL's NIMR witnessed an increase of 61% on a YoY basis to stand at PKR 124.1bln (CY22: PKR 77.3bln). primarily attributable to increased markup earned amounting to PKR 373.9bln (CY22: PKR 200.9bln) up by 86% YoY. The Bank's asset yield increased to 17.1% (CY22: 11.2%), whereas the cost of funds increased to 11.2% (CY22: 6.8%). Subsequently, the Bank's spread improved YoY (CY23: 5.8%; CY22: 4.4%). During CY23, non-markup income recorded a growth of 10% YoY to PKR 23bln (CY22: PKR 21bln) with a major contribution from fee & commission income clocking in at PKR 13.9bln (CY22: PKR 11.6bln) followed by forex income clocking in at PKR 6.8bln (CY22: PKR 7.2bln). The non-markup expense also grew by 37% YoY standing at PKR 72bln (CY22: PKR 52.7bln). The provisioning expenses declined to PKR 4.2bln (CY22: PKR 12.9bln). Subsequently, the net profitability of the Bank surged by 106% to stand at PKR 35bln (CY22: PKR 17bln). Non-markup income for the period totaled PKR 19.5bln, with fee and commission income contributing PKR 13.7bln, followed by forex income at PKR 3.8bln. Non-markup expenses stood at PKR 61bln, while provisioning expenses amounted to PKR 11.8bln. As a result, the Bank's net profitability for the period was PKR 33bln.

Financial Risk At end Sep'24, gross advances declines by 9% to PKR 814mln (CY23: PKR 896bln , CY22: PKR 831bln). The Non-performing loans of the Bank reported an increase of 38% to PKR ~35bln (Dec'23: 25.2, Dec'22: 15bln). The resulting infection ratio recorded an uptick to 4.29% as of ended Sep'24 (Dec'23: 2.8%). During 9MCY24, the investments increased to PKR 1.81trln (Dec'23: PKR 1.5trln). The resultant ADR declined to ~37% as of the end of Sep'24 (Dec'23: 46%). Government securities constitute 99.1% of total investments (end-CY22: 98.9%). At end-CY23, BAHL's paid-up capital stood at PKR 11,114mln. However, the Bank's equity base increased to PKR 126.6bln (end-CY22: PKR 95.2bln) attributable to improved profitability. Subsequently, the CAR of the Bank inclined to 15.8% (end-CY22: 14.7%) comprising of Tier, I CAR (12.011%), and for 9MCY24 CAR recorded at 19.63%.

Instrument Rating Considerations

About The Instrument The Bank issued unsecured, rated, listed and subordinated, ten years tenured Term Finance Certificates ("TFC" or the "Issue" or "Instruments") with an issue size of PKR 7bln bearing call option exercisable on or after five years of the issue date. As per the lock-in clause requirements for Tier II issues, neither profit nor principal will be payable in respect of the TFC, if such payment will result in a shortfall in the Bank's Minimum Capital Requirement (MCR) or Capital Adequacy Ratio (CAR) or Leverage Ratio (LR) or increase in any existing shortfall in MCR, CAR or LR. The Bank may call the TFCs (either partially or in full), with prior approval of SBP, any time on or after five years from the date of issue, subject to not less than 60 days prior notice being given to the investors. The call option once announced will not be revocable. In conformity with SBP Basel III Guidelines as per the Circular, the TFCs shall, if directed by the SBP, be fully and permanently converted into ordinary shares (subject to a cap of 145,000,000 shares) and/or be immediately written off (partially or in full) upon the Point of Non-Viability (PONV) Trigger Event. The Issue amount contributes toward the Issuer's Tier II Capital for capital adequacy ratio as per guidelines set by SBP and have a floating rate coupon priced @6MK+1.35% p.a. The instrument redeems 0.02% of the issue amount semi-annually during the first 9 years after the Issue Date and the remaining issue amount of 99.64% in two equal semi-annual installments of 49.82% each, in the tenth year.

Relative Seniority/Subordination Of Instrument The instrument is subordinated as to payment of principal and profit to all other indebtedness of the Bank, but superior to outstanding Additional Tier 1 issues and ordinary shares. However, the Tier II Issue ranks pari passu with any other Tier II capital issues of the Bank.

Credit Enhancement The instrument is unsecured and subordinated.

Credit Rating
