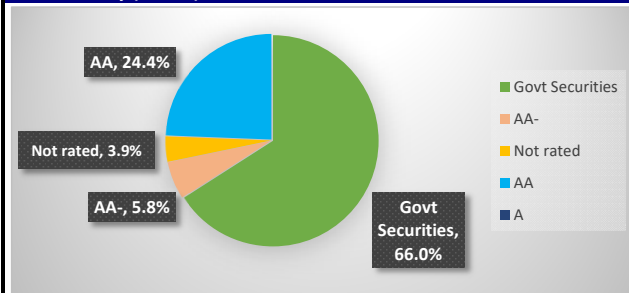

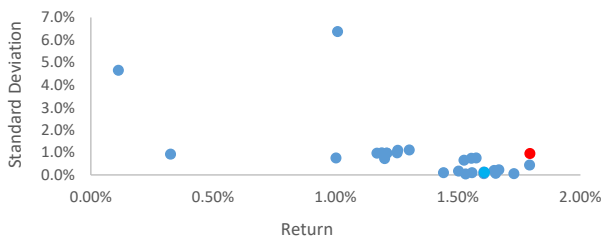

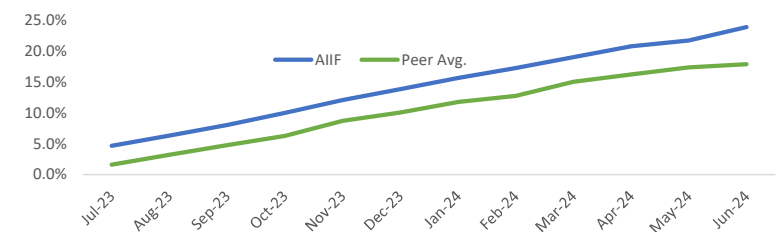
### Risk

### Commentary

Alhamra Islamic Income Fund (or the "Fund") reflects the fund's medium-risk profile. The credit quality of the Fund was ~66% in Govt Sec./AAA, ~24.4% in AA and ~5.8% in AA-. At the end Jun'24, the Fund had allocated ~58.6% in GoP Ijara Sukuk. Whereas, ~30.3% in banks in the form of cash and placements, ~4% was invested in Sukuks, ~3.3% in Govt backed Securities, and the remaining was invested in others. The AUMs of the Fund stood at PKR 12,197mln at the end of Jun'24. While the WAM of Fund is also stood at 815 days, exposing the Fund to high credit risk. The duration of the fund stood at 276.27 days at end of Jun'24, exposing the fund to interest rate risk. The top 10 investor concentration of the fund stood at 27.63% at end of Jun'24, exposing the fund to moderate redemption pressure.

Going forward, the Fund will invest in accordance with its authorized investment policy and maintain its exposure in Shariah Compliant instruments, however the allocations will be diversified appropriately. Material changes in the Fund's asset allocation strategy, impacting its credit quality and/or exposure to interest rate risk, would affect the rating. Risk may vary slightly from time to time considering the volatility of economic conditions.



# Stability Ratings Explained

The Stability rating is based on a detailed quantitative assessment of fund's portfolio and qualitative assessment of fund management. It provides the investors with an objective measure as to the main areas of risk to which the income funds are exposed, which is credit risk, liquidity risk and interest rate risk.

<b>Credit Risk</b>	<ul style="list-style-type: none"> <li>The foremost factor is credit risk, having the highest weight in the rating matrix. The opinion is based on review of various factors, including the fund's investment policies regarding credit risk exposure towards various market segments, individual and cumulative credit quality of the investment portfolio, the diversification of assets across investment types and issuers, and weighted average maturity.</li> </ul>
<b>Market Risk</b>	<ul style="list-style-type: none"> <li>The more complex part of evaluating a fund's stability involves determining the fund's sensitivity to the changing market conditions. PACRA assess market risk in the nexus of variables affecting the market value of the underlying portfolio. Market value can fluctuate due to a number of variables largely including interest rate, liquidity and operating environment.</li> </ul>
<b>Liquidity Risk</b>	<ul style="list-style-type: none"> <li>The liquidity of a security refers to the speed at which that security can be sold for approximately the price at which the fund has it valued. Securities which are less liquid are subject to greater price variability. While analyzing the liquidity of investment portfolio, PACRA considers the types of investments in the portfolio, the maturity structure, and secondary market liquidity.</li> </ul>
<b>Historical Returns Volatility</b>	<ul style="list-style-type: none"> <li>Funds having operational history of six-months or more, the variability in returns is gauged on standardized basis through coefficient of variation for each fund in a category. The coefficient of variation is calculated by dividing standard deviation of fund's monthly returns by average monthly return (SD of Monthly Returns/Average Monthly Return).</li> </ul>
<b>Asset Manager</b>	<ul style="list-style-type: none"> <li>Management scoring is derived from the asset manager rating of the company managing the fund. PACRA reviews the policies and procedures developed by the management to meet its investment objectives. Therefore, an assessment of the fund manager's qualification and experience, asset management company's capabilities and track record are an integral part to the fund rating process.</li> </ul>
